<u>PUBLIC COMMENT:</u> Justin Mankey – Question regarding traffic study, determined speed limit was 55, engineer still hasn't returned calls to no avail. Why is there no traffic study completed to officially determine speed limit? How to determine speed limit for intersection? Township will install 35 MPH signs on both sides of the road. Mr. Mankey still have issues with pointless stop signs as they are ignoring the signs. Mr. Jeffries suggests recourse to Court of Common Pleas as Township will not remove the stop signs. Manager Linck will ask engineers to justify 35MPH limit based on sightlines for traffic study.

Adam Hovanec – question about ordinance for review chickens. Supervisor Stanek said no change will be made. Mr. Hovanec asked next steps. Can file petition with Court of Common Pleas to challenge the ordinance based on aggrieved party and controversy. Mr. Hovanec asked about responsibilities of similar townships that allow chickens in the R2 district. What action can they take to challenge what is right and true and honorable? Solicitor Jeffries said Township will take no action based on the town hall meeting and reaction of residents. If ordinance done correctly, it can make enforcement and regulations. However, Board will not change ordinance.

Jackie Hovanec – asked for opinions of supervisors as to why the think ordinance change is wrong? Hovanec's disagree that definition of chicken is incorrect and should be listed as a domesticated animal. Solicitor Jeffries suggest file petition with Court of Common Pleas to challenge definition.

Vickie Group – speaks against change of R2 zoning ordinance.
